n 2022, PVA expanded its membership eligibility bylaws to welcome all Veterans **L** with Multiple Sclerosis (MS), which now accounts for 1 in 4 of all PVA members. Our national organization is committed to serving as a resource for veterans with MS as they navigate the ins and outs of living with the disease. Additionally, PVA service officers are trained in securing unique MS benefits from the VA and ensuring quality care for our veterans. PVA can also connect members with MS to resources outside of PVA - we have strong partnerships with prominent MS organizations such as the National Multiple Sclerosis Society and the VA's Multiple Sclerosis Centers of Excellence.

At the Chapter level, we are thrilled to launch our own program specifically for veterans in New England living with MS. We seek to be a source of information at the local level, sharing information and advocating for your needs. We also want to build a strong community for our fellow veterans with MS in every



Celebrating the Founders of the Bass Trail



t is with great sadness I am sharing the news that NEPVA has lost another great partner. 노 Bob "Soupy" Campbell passed away December 6th. The Chapter would like to send our heartfelt thanks and condolences to the Campbell family and all his loved ones.

For those who don't know, Soupy was one of the Co-Founders of the NEPVA Bass Trail from the American Eagle Bass Anglers (AEBA) club in Woburn, MA. The Trail will be entering its 25th year in the 2023 season. The Trail started with a one day Tournament on the Charles River in 1997 after Tiny LaFontaine contacted the Chapter with the idea and asked if we would be interested in getting our members out fishing in a Tournament. Some Chapter members had been traveling to fish in the PVA National Bass

Tournaments. Why not do a local one for those who could not get to the National Tournaments?

I started attending the AEBA meetings in Woburn to observe them plan the event. After the first few years they decided that it would be nice to hold a second Tournament at Lake Winnipesaukee in New Hampshire. We then started holding the 2nd Tournament annually there as well. We were moving to different locations each year when the Trail first started, eventually getting into the locations which now host the Tournaments each year. For years we had a few boats towed in the Halloween Parade in Woburn with Jim Wallack and myself strapped onto the bow throwing candy to the children. That's just one of the ways we started to spread awareness about the Trail.

This shows that our most successful programs are only possible due to the contributions of other great partner organizations and their volunteers. Tiny and Soupy may no longer be with us but their dream of a New England Bass Trail of Tournaments lives on each season.
