he PACT Act, officially The Sergeant First Class Heath Robinson Honoring our Promise to Address Comprehensive Toxics (PACT) act, was signed into law on August 10th, 2022. With the signing of the PACT act, there is an expansion of benefits for veterans who were exposed to toxins while in service. Some of the major changes of the PACT act include expanding VA healthcare eligibility to veterans with toxic exposures, and adding new presumptive conditions and locations.

Although the PACT act brings forth many changes, this article will focus on the expansion of benefits for veterans that were exposed to Agent Orange which may benefit those who served during the Vietnam era. This will include the new presumptive conditions and locations related to Agent Orange exposure.

Historically, the VA has presumed certain illnesses and cancers as being

caused by exposure to Agent Orange. With the PACT act expansion, two new conditions have been added. The following conditions are now presumed as being caused by Agent

1) Hypertension (High Blood

2) MGUS or Monoclonal Gammopathy of Undetermined Significance (a blood disorder which affects plasma within bone marrow).

1) Service in Laos from December 1st, 1965 until September 30, 1969

- 2) Any U.S. or Royal Thai Military bases in Thailand from January 9, 1962 until June 30, 1976
- 3) Guam or American Samoa or in the territorial waters off of Guam or American Samoa from January 9, 1962, until July 31, 1980
- 4) Johnston Atoll or on a ship that called at Johnston Atoll from January 1, 1972, through September 30, 1977
- 5) Cambodia at Mimot or Krek, Kampong Cham Province from April 16, 1969, through April 30, 1969

These new locations are in addition to the previous service locations for presumption to exposure which include:

1) Service in the Republic of Vietnam, or on a U.S. Military

vessel that operated in the inland waterways of Vietnam, or on a vessel that operated within 12 nautical miles from Vietnam and Cambodia (Blue Water Navy) from January 9, 1962 until May 7, 1975.

- 2) Service in or near the Korean DMZ from April 1, 1968 until August 31, 1971.
- 3) Service in the Air Force in which the veteran regularly and repeatedly operated, maintained, or served onboard a C-123 aircraft known to have been used to spray an herbicide agent during the Vietnam era.

With the new list of expanded conditions and locations based on herbicide exposure, chapter members who believe that they may qualify for service connection based on Agent Orange exposure should contact their local National Service Officer or PVA office so that they can assist with any actions that may be required.

T mportant: Any Veteran who believes that they may be entitled to benefits based on exposure to Agent Crange, whether it is due to serving within one of the newly recognized presumptive locations, and/ or due to having a diagnosis of one of the newly recognized presumptive conditions, should contact a PVA office prior to August 9, 2023. If granted, claims filed under the new PACT act prior to the August 9th Deadline, will be backdated to August 10th, 2022, the date of the PACT act being signed into law.
