Benefit Services

Connecting our members to benefits they are due through their service is perhaps the most important thing that our Chapter does. To do this, we routinely work with other Veteran Service Organizations, local nonprofits, and the VA in helping our members have their earned benefits made known and available to them. Over the last fiscal year, we are proud of the many ways in which we have assisted in identifying and securing veterans' benefits for our members. We are fortunate to have hard working National Service Officers (NSO's) in our Chapter who help ensure that all benefit services to our members are made available and assist our members, veterans, and their families throughout the New England region. In the midst of so many good and worthy programs and initiatives throughout our Chapter, benefit services has and will continue to remain a top priority for us.

Chapter Administration

The Chapter Office is located at 1208 VFW Parkway, Suite 301, West Roxbury, MA 02132. The Chapter is staffed by an Executive Director, Director of Government Relations and Community Affairs, a bookkeeper, and several active volunteers. The day-to-day work of the staff is informed by the Chapter President and Board of Directors, as the staff implements the direction and vision of the collective Board. The staff and Board of Directors work tirelessly to serve every member of the Chapter with care, concern, appreciation, and dignity. Board of Director meetings are held virtually and at the Chapter office typically on the 3rd Wednesday of each month.

SPORTS AND RECREATION PROGRAMS

The Chapter’s sports and recreation programs provide members and other persons with disabilities the opportunity to participate in quality programs with a variety of activities. We are proud to offer many adaptive sports, and we have found that participation in adaptive sports and recreational activities provides immeasurable benefits to everyone involved as it can help improve self-esteem, encourage good health, and promote friendship among our members, staff, and volunteers.

One of our most sought-after sports programs are the Winter and Summer Sports Clinics. These clinics are conducted through the VA Boston Healthcare System in partnership with other VAMC’s who host them at different locations throughout New England. Each year the VA New England Healthcare System invites veterans with spinal cord injuries, orthopedic amputation, visual impairments, certain neurological problems, and other disabilities to participate in these clinics. The Winter Sports Clinic promotes rehabilitation by instructing physically challenged veterans in adaptive Alpine skiing and introduces other adaptive activities and sports as well, such as downhill skiing, air rifle shooting, seated yoga, massages, and sled hockey with the Ice Vets Team. In January 2024, Chapter Board Vice-President Mike Moran, Chapter President Brad Carlson, Executive Director Mark Murphy and others were happy to support and attend the Winter Sports Clinic in

New Hampshire, with the Chapter generously donating to the New England Healing Sports Association, who helps put on the clinic in partnership with the VA. The Summer Sports Clinic was held in Warwick, RI in July 2023, and a wonderful time was had by all.

In Summer 2023 we supported our members and volunteers who attended the National Veterans Wheelchair Games in Portland, Oregon. The National Veterans Wheelchair Games is the world’s largest annual wheelchair sports and rehabilitation event solely for veterans. The event is designed for veterans with spinal



cord injuries, amputations, multiple sclerosis, or other central neurological conditions who require a wheelchair for athletic competition. Our Chapter delegation won several medals in Portland, and they represented the very best values of PVA throughout the week. A lot of Chapter time and resources goes into supporting the Games each year, and it is our honor to participate in and support this seminal event.

In FY24 The New England PVA Bass Trail Program was run by members of the American Eagle Bass Anglers with the support of Local and Federation members. Anglers with disabilities were paired with boaters for days of competitive fishing. The partners competed as a team and the team with the largest weight for their limit took home the first-place trophies. The anglers competed in as many events as possible, and lunker prizes were awarded for the largest bass taken at each tournament. This tournament trail was completely free for Chapter members. Bass Trail program locations included Charles River, the Newton Yacht Club, Lake Winnepesaukee, Camp Robindel, Moultonborough, NH, and Camp Wavus, Maine.

Our Chapter Air Rifle Program is a burgeoning program and is open to participants of all skill levels, from introductory to advanced. Trained coaches and top instructors from around the country donated their time to assist veterans learn what it takes to compete in air guns and help seasoned competitors hone their skills. Bowling throughout the year also was a recreational and competitive sport that several Chapter members enjoyed participating in.

In partnership with our friends at PVA, on Veterans Day weekend in November 2023 we hosted a Boccia Tournament at the Marriott in Quincy, MA. It was very well attended, especially by our members and friends from Building 8 at the Brockton VA. We received overwhelming positive feedback from the participants and attendees on how well run and fun the Boccia Tournament Veterans Day weekend was.



CHAPTER ADVOCACY & LEGISLATIVE WORK

Fiscal year 2024 was the final year of the 118th congressional session. Our Chapter placed a very strong emphasis on our federal advocacy efforts to best advance PVA legislative priorities by the end of the session. Throughout the fall and early winter, we did a heavy advocacy push to encourage our congressional delegation to formally support our legislative priorities. For the first time in Chapter history, our Board supported an additional trip to Washington, D.C. in September 2023 to help ensure we reached as many legislators as possible. This trip proved to be very effective, and we heard feedback that other Chapters throughout the country are now considering additional advocacy trips of their own.

We started the new year continuing our advocacy in the district and preparing to travel back to Washington, D.C. in June 2024 for the Pushing Access Forward 2024: PVA's Annual Advocacy Legislative Seminar. As in years past, we had an opportunity to hear directly from the national staff and various government officials on PVA's legislative priorities. We were also thrilled to get back into the Capital building and meet with members of the New England congressional delegation and their staff. Our Chapter continued to promote National PVA's VoterVOICE platform, which is an essential tool in our advocacy efforts. We frequently advertised VoterVOICE opportunities on Facebook, in our newsletter, and at Chapter and community events.

As we enter a new fiscal year, our Chapter will continue to foster strong relationships with the New England congressional delegation to ensure they understand and remain responsive to the challenges facing our members. We will also continue to monitor and engage on issues impacting our membership at the state and local levels as well.

COMMUNICATION

Staying in touch with our members via email and phone, producing and distributing regular newsletter publications, and creating public awareness about issues of concern for our members is of utmost importance to the Chapter. Our “CordWord” newsletter is published each month and provides current information about Chapter programs, activities, and other issues of importance to our members. Articles and information appearing in the newsletter contain reports from various program directors, Chapter officers, volunteers, legislative news (national and local) and other items of interest.

The CordWord is distributed to our members, affiliate members, patients on the SCI units at the Brockton and West Roxbury VAMC's, as well as the three clinics and three primary care clinics in our spoke system. Distribution extends to volunteers, VAMC officials, PVA National officers and directors, all Congressional members representing the New England region, and all Chapters of PVA for a circulation of approximately 1,200, both in print and online. The Chapter primarily distributes the CordWord via email to its readership, but also distributes it in print to each VAMC and Congressional Legislator, as well as those members requesting copies. Current and archived copies are always available in the office and on the Chapter website.

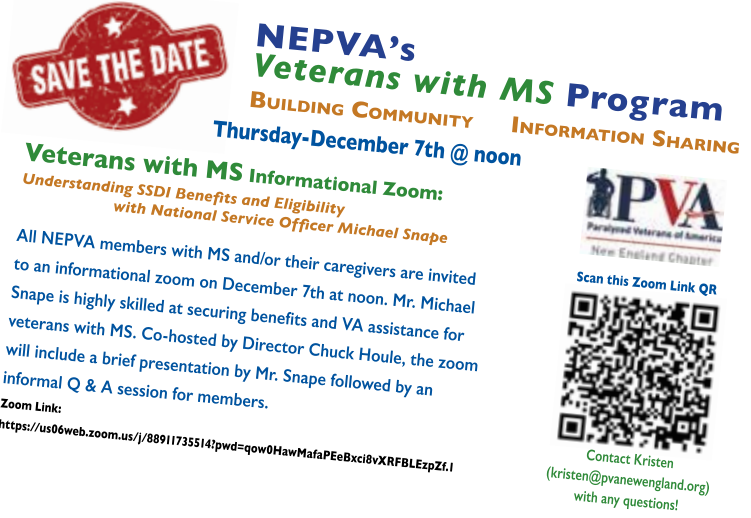
In addition to our Chapter website, which we constantly keep updated with fresh content and upcoming programs and events, we also email our members regularly to keep them up to date on what is happening throughout the Chapter. We conduct several direct mailings each year to stay connected with our members. Our Chapter Facebook page has been an increasingly effective way to disseminate important information to members, and overall engagement on social media has increased exponentially over the fiscal year.



MEMBERSHIP

Our Chapter has over 750 members. Beyond engaging with our members through our historically strong sports and recreation programs and other more formal community outreach initiatives, we have also engaged our members in several other ways during the last year. We had a successful membership banquet in August 2023 at the Italian American War Veterans Post 45 in Marlborough, MA, where over 100 of our members and their families gathered in fellowship and support of the Chapter. We also held periodic membership meetings held virtually throughout the year, where we address a particular topic of interest for our members. We typically use these meetings as a space where we can glean feedback directly from our members on what is going well at our Chapter and what can be improved.

One of the growing programs in service to Chapter members is our NEPVA Veterans with MS Program. In 2022, PVA expanded its membership eligibility bylaws to welcome all veterans with Multiple Sclerosis (MS), which now accounts for one in four of all PVA members. The national organization is a resource to help veterans with MS navigate how to best live with the disease. PVA service officers are also well trained in securing unique MS benefits from the VA and ensuring quality care for our veterans. To respond to this change in membership eligibility, our Chapter created our own Veterans with MS program to best serve the needs of our new members.



The NEPVA Veterans with MS program is a source of information at the local level, sharing information and advocating for the needs of this growing veteran population. We also want to build a strong community for our fellow veterans with MS in every New England state.

Here are some highlights of our program from FY24:

- Offering a Zoom with leading social workers in the VA Health care system to inform members with MS about the benefits and opportunities available to them.
- Hosting an informational Zoom with PVA's Senior NSO Michael Snape. Michael gave a presentation on social security benefits related to MS that our members found very helpful.
- Continued effective communication with members by creating flyers, writing newsletter articles, and Facebook posts on program activities.

We have received enthusiastic and positive feedback from our members for this program, and we look forward to continuing to serve our members' needs in this space.

FUNDRAISING

FY24 saw the Chapter's fundraising program go to the next level. We received generous grants from The Pilot Company, The Red Sox Foundation, and the Disabled National Veterans Foundation. We also saw our individual donor engagement increase exponentially, especially with our major donor outreach. As one of our largest fundraising events of the entire year, our August 2023 Annual Golf Tournament at Olde Scotland Links in Bridgewater, Massachusetts raised the most funds we have ever received in the recent history of the Chapter. In FY24 the Chapter also benefitted from several generous bequests, which is also a credit to our growing and intentional planned giving program. The Chapter will continue to develop and grow precisely because of the generosity of our donors, grant funders, and corporate partners.

The Chapter has three main approaches to its fundraising work:

- working with individual donors,
- applying for grant funding,
- engaging with corporate sponsors.
