

Advocating for Veterans on Capitol Hill: New England PVA Attends 2025 Advocacy and Legislation Seminar

From June 10–14th representatives from our New England Chapter traveled to Washington, D.C. to participate in PVA's Annual Advocacy and Legislation Seminar. This important event brought together Chapters from across the country to amplify the voices of paralyzed and disabled veterans and ensuring that their needs and rights remain a national priority.

Our New England delegation included me, Chapter President and PVA National Director Brad Carlson, Vice-President Mike Moran, and longtime Chapter volunteers and caregivers Kathy Carlson and Denise Pease. The week began with a comprehensive training seminar led by PVA's national staff on Tuesday, preparing us to bring a strong, unified message to Capitol Hill.

On Wednesday and Thursday, we met with several members of Congress and their staff to advocate for key legislative priorities that impact the lives of veterans with spinal cord injury and disease. Brad Carlson delivered a compelling case for the passage of the Autonomy for Disabled Veterans Act (H.R. 2245 and S. 1644), which would expand vital home modification grants. Mike Moran advocated passionately for increased access to adaptive vehicle modifications through H.R. 1364, emphasizing the importance of mobility and independence for paralyzed veterans. I stressed the urgent need for full funding and adequate staffing at the VA, particularly within the Spinal Cord Injury and Disorders (SCI/D) system of care, where recent cuts threaten the quality of services veterans depend on. Meanwhile, Kathy Carlson and Denise Pease

brought a powerful personal perspective to the conversation, sharing their lived experiences as caregivers to veterans with spinal cord injuries - a role that is too often under-recognized in policy discussions.

One of the standout moments of the week was our in-person meeting with Senator Bernie Sanders of Vermont, a longtime

advocate for veterans. Senator Sanders commended our Chapter's incredible work and echoed concerns over current staffing

shortages and budget constraints at the VA. His continued support and attentiveness to our mission reminded us why

Washington Update

House Committee Hearing Examines Veterans Legislation

On June 12, the House Veterans' Affairs Committee, Subcommittee on Health met to examine a dozen bills impacting the availability of health care for veterans. In a statement for the record, PVA strongly endorsed the CHAMPVA Children's Care Protection Act (H.R. 1404), which would allow dependent children to retain VA health coverage until age 26. For most Americans with health insurance, their adult children can remain on their plan until this age with no separate premium, as mandated in the Patient Protection and Affordable Care Act (ACA). That is not the case with the Civilian Health and Medical Program of the Department of Veterans Affairs (CHAMPVA). Coverage for children under CHAMPVA currently expires when they turn 18, unless they are full-time students. In this case, they continue to receive coverage until they turn 23, stop attending school full-time, or get married. CHAMPVA and the military's TRICARE programs were not affected by the ACA, so they required separate congressional action to extend these benefits to children up to age 26. Congress addressed this discrepancy for TRICARE in 2011, but they have yet to act on similar legislation that would make the change for CHAMPVA.

The VA testified in opposition to this bill. While we agree that CHAMPVA was not directly affected by the ACA, we disagree with VA's assertion that

CHAMPVA is not health insurance. For example, certain types of care and services require preauthorization. This approval is extremely important, and the failure to obtain it may result in denial of the claim. We also pointed out that the Congressional Research Service (CRS), which advises Congress on programs like this, seems to view it the same way. In an October 2024 report to Congress on VA health-care programs for dependents and survivors, CRS said, "CHAMPVA is primarily a health insurance program where certain eligible dependents and survivors of veterans receive care from private sector healthcare providers..." The bottom line is that the government shouldn't deem veterans' dependents and survivors less worthy than civilians for support, and we urge Congress to correct this inequity as soon as possible.

The subcommittee also reviewed and discussed the Veteran Caregiver Reeducation, Reemployment, and Retirement (3R) Act (H.R. 2148), which would provide greater support for the family caregivers of veterans. It would ensure family caregivers enrolled in CHAMPVA remain enrolled for up to 180 days following their dismissal from the Program of Comprehensive Assistance for Family Caregivers, unless they have been dismissed for fraud, abuse, or mistreatment. Other provisions in the bill would offer bereavement counseling, job training assistance, and help with professional

relicensing costs to help caregivers ease into the workforce or into retirement once their time as a caregiver has concluded. Caregivers are often the most important component of rehabilitation and maintenance for veterans with catastrophic disabilities, and their welfare directly affects the quality-of-care veterans receive.

Finally, PVA also testified in support of H.R. 2605, the Service Dogs Assisting Veterans Act, which requires the VA to establish a competitive grant program to fund nonprofit organizations that provide service dogs to veterans with a variety of disabilities, such as mobility or vision impairments or PTSD. Service dogs provide invaluable assistance to disabled veterans with the greatest support needs, allowing them to live more independent lives in their communities. This bill would require nonprofit organizations seeking a grant to submit an application to the VA Secretary that includes a description of the training that will be provided by the organization to eligible veterans; the training of dogs that will serve as service dogs; the aftercare services that the organization will provide for the service dog and eligible veteran; the plan for publicizing the availability of service dogs through a marketing campaign; and the commitment of the organization to have humane standards for animals. Passage of this legislation will increase veterans' access to service dogs and their independence.

Earlier this month our Chapter delegation traveled to Washington, D.C. for the 2025 PVA Advocacy and Legislation Seminar, where we joined fellow Chapters from across the country to raise our voices on the issues that matter most to our members. I was especially proud to be joined by Chapter Vice-President Mike Moran who attended his first-ever PVA advocacy seminar. Mike represented our Chapter with passion and professionalism, asking sharp questions and making a real impact in our meetings with lawmakers. It's no small task to dive into federal policy discussions on your first trip, and Mike handled it like a seasoned pro. Mark Murphy, my wife Kathy, and Chapter volunteer Denise Pease were also huge contributors in making the week such a success!

During our time on Capitol Hill, I personally focused on advancing improvements to VA home modification grants

in our conversations - a critical need for many of our members. Accessible housing is not a luxury; it's a foundation for independence and quality of life. I informed Congressional members that the Home Improvements and Structural Alterations (HISA) grant program rates have not increased since 2010, but the cost of home modifications and labor have risen more than 50% during that time. Sadly, many

of our veterans incur astronomical out of pocket expenses precisely because the grant amount is too low to cover the costs of accessible home improvements. I was encouraged by the interest and support we received from several members of the New England congressional delegation. These conversations are ongoing, but we left D.C. with renewed confidence in our ability to effect change.

Looking ahead, I'm excited to share again that our Chapter will be sending a strong team of athletes to the 2025 National Veterans Wheelchair Games in Minneapolis, Minnesota in July. I'm honored to be competing too and am looking forward to representing our Chapter in several events. The Games are always an inspiring reminder of what's possible through adaptive sports and peer support - and I can't wait to see my fellow New England athletes in action.

And of course, one of our favorite Chapter traditions is just around the corner: our Annual Chapter Clambake, which will be held on Sunday, August 24th at the ITAM Post 45 in

Oppose Dismantling the VA's SCI/D System of Care

Time has proven that the Department of Veterans Affairs (VA) is the best provider of care for veterans with spinal cord injuries and disorders (SCI/D). It is essential that leaders in Washington, DC know this so they can ensure the VA's SCI/D system of care is protected. In recent years, we have seen cracks begin to develop in the system as it struggles with numerous clinical vacancies and infrastructure deficiencies that compromise veterans' care. We need to reverse these trends.

Join PVA National President Robert Thomas by signing your name to ensure Congress and the Administration know that its SCI/D system of care is necessary for the health of paralyzed veterans and is an essential part of the VA system. Our goal is to uplift your voice with the petition when President Thomas testifies before a Joint Session of the House and Senate Veterans' Affairs Committees this spring.

Petition Text

We urge you to oppose dismantling the Department of Veterans Affairs' (VA) Spinal Cord Injuries and Disorders (SCI/D) system of care, as veterans overwhelmingly prefer to receive their care at the VA and community providers are not equipped to adequately meet their needs. Veterans with an SCI/D tend to have complex medical needs, resulting in a need to see a multitude of medical specialists in a variety of different fields. The cohesive medical care provided by the VA medical system ensures that veterans can receive the care they need in one place. It also alleviates the often burdensome need to forward their complex medical history from one specialist to another to ensure their complex cases are fully cared for.

The VA's SCI/D system is the crown jewel of its health care system. The VA's integrated approach enhances continuity of care and fosters trust among veterans, who value the specialized services tailored to their unique needs. The failure in recent years to properly fund, staff, and invest in the system's infrastructure is slowly dismantling the SCI/D system of care, leaving paralyzed veterans with inferior care options in the community. The United States government must affirm its commitment to those who served, particularly those with the most significant disabilities, and ensure they receive the best possible care where they feel safe and comfortable.

PVAction Force Update: Sign Our Petition

We need your help as we raise our united voice through our petition urging Congress to oppose any efforts to dismantle the VA's spinal cord injuries and disorders system of care. Our goal is to reach 5,000 signatures by June's Advocacy/Legislation Seminar. We currently have over 2,800 signatures. When we meet with members of Congress in June, we plan to share the number of individuals in their states and districts who have signed the petition to raise awareness on how important this is to us. Veteran Usability Recruiting Opportunity

PVA recently participated in a briefing by VA's Section 508 Compliance Office, which ensures systems and information technology platforms are compliant with federal laws related to digital accessibility. According to the office, their efforts have increased website compliance from 26 percent in 2022 to 98 percent today.

The VA would like to hear from veterans about the accessibility barriers they encounter. Participating in user experience research studies pro-

vides them with a direct link to veterans about how they engage with VA platforms, apps, and other VA systems. If you would

The Universal Access Program offers guided adaptive recreation programs year-round and statewide. We strive to make our programs accessible to as many people as possible. We want our programs to feel welcoming, safe, and approachable to people with disabilities.

Our structured programs offer adaptive equipment and gear. Our staff have experience in providing activity instruction and support to people with a broad range of disabilities. We choose our programs locations to be as accessible as possible to people using mobility devices. Our program bases have accessible parking close by.

You will need to pre-register to attend a program. We understand that our program designs and locations may not be accessible to you depending on your individual situation. If you need an accommodation, please let us know during registration. We will do our best to provide the type of support you need to take part in our programs.

Each program has Essential Eligibility Criteria (EEC). For safety and risk management considerations, everyone who attends our programs must meet these EEC. If you have questions about the EEC or about accommodations at programs, please get in touch with us.

Service Officers Report

Summer is here, and with it the arrival of warmer temperatures. Make sure to stay hydrated and cool during the higher heat prevalent during summertime.

This article expands on the May 2025 CordWord article which discussed the SAH (specially adapted housing) grant.

An alternative grant known as the Temporary Residence Adaptation (TRA) grant is also available for those chapter members who qualify for the SAH (specially adapted housing) or SHA (special housing adaption) grants. The TRA grant assists chapter members with service-connected disabilities who are temporarily living in a family member's home; with the purpose of making that home more accessible. The TRA grant provides financial assistance in adapting a family member's home to meet specific needs related to the individual's service connected disabilities. For chapter members eligible for the SAH (specially adapted housing) grant, the TRA grant can be up to \$49,062. For chapter members eligible for the SHA (special home adaptation) grant, the TRA grant can be up to \$8,760. The May 2025 CordWord article provided the criteria for eligibility for an SAH (specially adapted housing) grant. The criteria for SHA (special home adaption) is different and is noted below.

A veteran must be entitled to compensation under chapter 11 of title 38, United States Code, for a disability that meets the requirements described in paragraph (c) of this section (shown below)

VA has rated the disability as permanently and totally disabling and it:

- (1) Includes the anatomical loss or loss of use of both hands;
- (2) Is due to deep partial thickness burns that have resulted in contracture(s) with limitation of motion of two or more extremities or of at least one extremity and the trunk;
- (3) Is due to full thickness or subdermal burns that have resulted in contracture(s) with limitation of motion of one or more extremities or the trunk; or
- (4) Is due to residuals of an inhalation injury (including, but not limited to, pulmonary fibrosis, asthma, and chronic obstructive pulmonary disease).

If chapter members believe that they may eligible for the TRA grant benefit under the eligibility requirements for either the SAH (specially adapted housing) or SHA (special home adaptation) criteria, they should reach out to their local National Service officer for assistance in applying for the grant.

REMINDER: Seeking Potential Class Members in Lawsuit Against Car Rental Company

Disability Rights Advocates (DRA) filed a class action lawsuit against Hertz for failing to provide hand controls in most of the types of vehicles they offer for rent. DRA is seeking policy changes on behalf of a proposed class of people with mobility disabilities. If you have ever tried to rent a vehicle with hand controls from Hertz but could not get the type of vehicle you wanted, DRA wants to hear from you! DRA has put together a simple survey to collect potential class members' contact information. DRA will contact everyone who fills out the form. You can access the survey using the QR.. House Passes Legislation Supporting Employment of People With Disabilities

The first week of June, the House of Representatives passed several pieces of legislation, most of which related to the Small Business Administration (SBA).

One of these bills, H.R. 1634, the Think DIFFERENTLY About Disability Employment Act, would establish a memorandum of understanding (MOU) between the SBA and the National Council on Disability. The MOU seeks to provide assistance for people with disabilities who are interested in becoming entrepreneurs or who want to be self-employed. It would also help small businesses with hiring individuals with disabilities and increase accessibility for the

workplace. Additionally, it increases outreach and education to help more people with disabilities access information about how to become business owners. H.R. 1621, the Entrepreneurs with Disabilities Report Act of 2025, also passed the House. This bill would require the SBA to submit a report to Congress highlighting challenges faced by entrepreneurs with disabilities. These bills will now move to the Senate for further consideration.
